







## Η θέση της Ελλάδας στις Δράσεις MSCA SE στο πλαίσιο του HE







# 2021 and 2022 Staff Exchange Call

**2021, 209 proposals from 28 countries,**

**71 selected**

- **CHE:** 32 proposals
- **ECO:** 6 proposals
- **ENG:** 70 proposals
- **ENV:** 21 proposals
- **LIF:** 18 proposals
- **MAT:** 4 proposals
- **PHY:** 15 proposals

**2022, 196 applications, 189 eligible and evaluated,**



The Registry aims at monitoring startup entrepreneurship progress based on specific KPIs, at supporting them with benefits and incentives, and to operate as a dashboard of metrics to attract investors from Greece and abroad!

# Bilateral and Multilateral R&D Cooperation Programs

**Who can participate ?**

**Higher Education Institutions, Research & Technological Organisations, Private Enterprises, NGOs**

**Budget**

**Program budget: jointly agreed upon – typically 2-10 m € (3 years)**  
**Project Funding : jointly agreed upon – typically 100-250 K € / project**

**Timeline**

**Launching of Joint Call (open for 2 months) (to be mutually agreed)**  
**National Evaluation – peer review - Joint Committee**  
**Duration of projects : 2-3 years**
