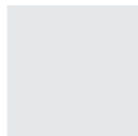
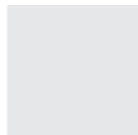
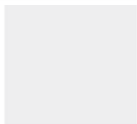

Our services are targeted at:

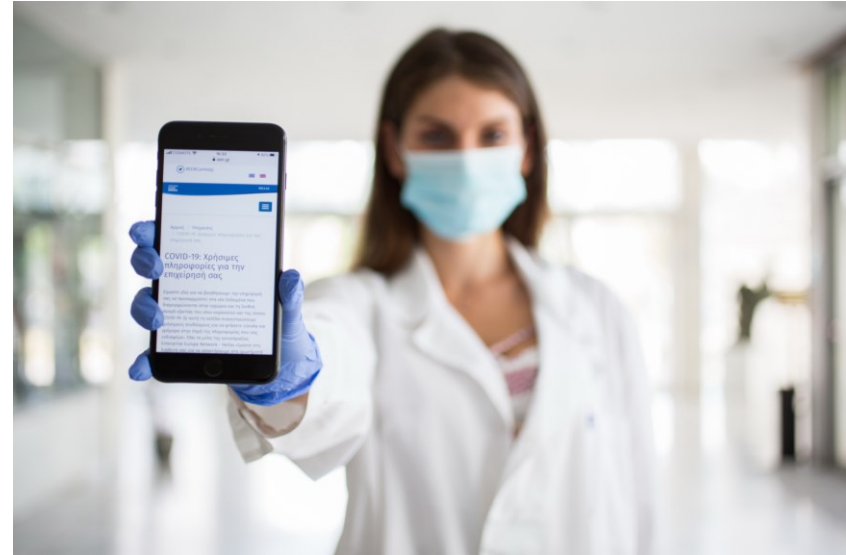

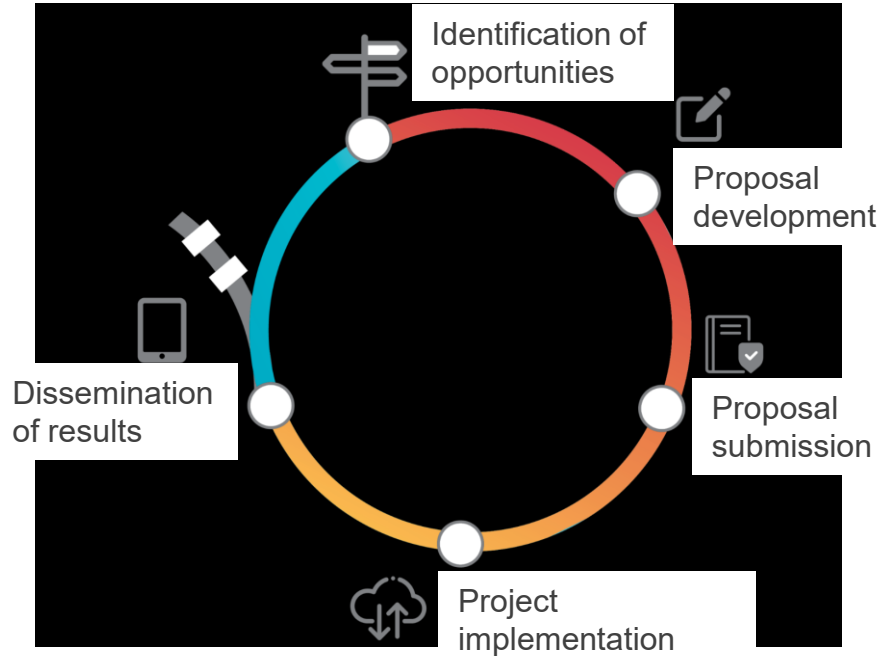

# MSCA Self assessment tool: gives feedback on your answers..

**Under Marie Skłodowska-Curie Postdoctoral Fellowships (MSCA-PF), may a proposal that was rejected under a previous MSCA Postdoctoral Fellowship call be re-submitted?**



- 1) In all cases, resubmission is allowed
- 2) It depends on score obtained the year before resubmission
- 3) It depends on the profile of the host organisation
- 4) It depends on the country

Applicants will be allowed to re-submit a proposal that was rejected under the previous Horizon Europe MSCA Postdoctoral Fellowship call, unless the proposal scored below 70%.

**Non-academic placement: when does it take place?**



- 1) At the beginning of the fellowship period.
- 2) Any time within the fellowship period.
- 3) After the fellowshpi period.
- 4) There is no non-academic placement in MSCA PF.
